**Participants must stay the entire event, as all roads are going to be blocked to through traffic except for emergency vehicles.**

- Trunk or Treat Down MainStreet will be Monday, October 31, 2023 from 6pm-8pm in Downtown Deming. Gold Ave will be blocked off from Pine St to Ash St and will be closed from 5pm-9pm. Thus, enough time to set up and tear down.
- Each organization MUST be registered no later than **October 27, 2023 @ 12:30pm**. Late participants will not be accepted.
- Set up will be at 5pm on the evening of the event and must be completed by 6pm. If you have any questions, please go to the Deming MainStreet table located at Leyendecker Plaza (Wells Fargo Fountain).
- ALL candy MUST be individually wrapped & packaged and not opened prior to the event. All treats must be commercially prepared. No homemade treats permitted. Each organization is responsible for ensuring their candy is unopened, as safety is our overriding concern.
- Each organization is responsible for maintaining their area in a neat, clean condition and for the appropriate disposal of any trash generated or collected.
- Each organization's possessions must be removed at the end of the event.
- No vendor is permitted to sell any items.
